**ANNEXURE-A**

**(TERMS & CONDITIONS)**

1. a) The sealed covers containing tenders shall be addressed to the V.C., & M.D., G.C.C. Ltd., superscribing on the envelope as Tender for purchase of condemned vehicles.  
b) The tenders received will be opened on the date of tender-cum-auction by the committee in the presence of tenderers or their authorized representatives.
2. The firms/ individuals interested in participating in tender-cum- auctions shall pay EMD of Rs.3,000/- (Rupees Three thousand only ) for each vehicle by way of D.D. drawn on any Nationalized Bank in favour of GCC,Ltd., Visakhapatnam payable at Visakhapatnam. The Bank Draft thus obtained shall be enclosed to the tenders. Cash/Cheques will not be accepted. No exemptions for anybody including Co-operative Agencies/ small scale industries in the matter.
3. Sealed tenders will be accepted in all working days and upto 1.00 P.M on 30.06.2017. The sealed tenders shall be presented either by the firms/ individuals or their authorized representatives before the date and time stipulated. This office will not take any responsibility for delayed receipt of the tenders sent by post or for the tenders lost in transit.
4. All the parties or their authorized representatives shall be present 15 minutes before the time specified of conducting auction for opening of tenders on the day and at the place indicated in the tender notice so that they can witness the tender proceedings when the tenders are opened. Only the parties who pay the EMD will be allowed in the auction hall.
5. The tenders which are not in prescribed format and not accompanied with prescribed EMD will summarily be rejected.
6. In all matters of doubt/ disputes, the decision of the Tender cum auction Committee will be the final and binding on the parties.
