The interested TDCC/Beekeepers Societies / Registered firm/ Agencies in the business of supply Rock Bee Raw Honey (Multi floral) can participate in MSTC e-auctions by registering themselves with MSTC as seller/vendor for e-auctions.

Every Agency participating in the tender should furnish their GST registration, address proof, Income Tax returns and other details etc., if any, for being allowed to participate in the said e – reverse auction.

The pet bottle to be affixed with details of the quality of Honey to be supplied to GCC. Agencies without the analysis report shall not be allowed to participate in e-reverse auction. Only those samples that comply with FSSAI Quality Parameters for Honey shall be allowed to participate in e-tenders. The analysis charges shall be borne by the supply agency. The sample should reach the General Manager (Mktg), Girijan Cooperative Corporation Ltd., Opp VMRDA Park, East Point Colony, Visakhapatnam, Pin 530017 well in advance ie., on or **before 13.09.2024**. The Bids received without the Honey Samples and Quality Test Report will not be considered.

Quality specifications:

Rock Bee Raw Honey:

- Honey shall be from Apis dorsata colony/from wild bee colony from forest or covering agriculture fields
- Should be filtered with cloth and should not contain heavy pollen and foaming contents and it shall be free from fermentation and turbidity
- It should have pollen content as per FSSAI parameters and good looking and should have the floral aroma

- Moisture content shall be less than 25%
- It shall not emit any foul smell and must taste sweet with good floral aroma.
- Honey with bitter taste cannot be accepted.
- Honey's qualitative Fieche's test should be "negative"
- It shall be free from Sugar and Jaggery solutions or any other adulterants.
- It shall be stored in steel / aluminium / Food grade plastic cans only.
- The Honey shall comply with FSSAI Quality parameters and Authenticity tests.
- The Agencies have to furnish / submit copy of the quality details certified by CALF, NDDB, Anand or any other Govt. Lab conducting all the FSSAI parameter tests.
- GCC shall take delivery in batches of 10 MTs, provided every batch of 10 MTs of Honey shall pass through the FSSAI Quality parameters and Authenticity Tests. The test charges shall be borne by the Suppliers.
- A competent person will go through the quality of Honey during the course of deliveries.

- 1. Registration: The TDCC/Beekeepers Societies / Registered firm/ Agencies who are interested to supply the Rock Bee Raw Honey (Multi Floral) through e-procurement shall get themselves registered with MSTC as supplier before commencement of the e- procurement process.
- 2. For registration interested firms may contact:

- 3. Every TDCC/Beekeepers Societies / Registered firm/ Agencies should furnish their Society registration / or any relevant document(s), address proof, with details of GST registration in Commercial Taxes Department etc., if any.
- 4. The supplier shall remit required transaction fee (non refundable) with MSTC Visakhapatnam for participating in e reverse auction.
- 5. The TDCC/Beekeepers Societies/Registered firm/Agencies participating in etender shall submit a sample of 1000 gr. Honey in pet bottle along with the Analysis Test obtained from CALF, NDDB, Anand for the following FSSAI Parameters and Authenticity Tests. The pet bottle to be affixed with details viz. lot number, quantity, source etc.
- 6. The samples to reach the General Manager (Marketing), GCC Ltd., Visakhapatnam on or before 13.09.2024. Without samples the agencies will not be allowed to participate in E-auctions.

Only those parties who have submitted samples well before the date prescribed with the test report of CALF, NDDB, Anand for FSSAI parameters and authenticity test will be allowed to participate in the e- procurement.

- 7. Rate: The rate quoted for Rock Bee Raw Honey (Multi Floral) must be per quintal (inclusive of all taxes) and delivery at Honey Processing Unit, Chittoor/ Rajahmundry.
- 8. EMD: All interested Agencies shall remit EMD as prescribed on any working day before commencement of the (e-reverse auction) e- procurement process. The EMD must be remitted by way of NEFT/ RTGS in the account of MSTC limited Visakhapatnam- Account Number- 200013950693, INDUSIND bank, IFSC code: INDB0000581, MICR code: 530234001, branch. - 9. After sending the RTGS, the firm should send E- Mail to <u>krama@mstcindia.co.in</u> requesting to participate in the e- procurement and should state the following.

- 10. The EMD of the successful party will be converted in to Security Deposit
- 11. In case the successful tenderer fails to supply the stocks as per the quality or quantity the EMD/ security Deposit will be forfeited
- 12. No interest shall be payable on the EMD amount deposited by the party at any time.
- 13. No request for transfer of EMD (or) confirmation order shall be entertained.
- 14. The Agencies shall supply Rock bee Raw Honey (Multi Floral) with correct weighment and quality as per prescribed specifications and as per issued Orders by GCC within the time stipulated in the order. If the Agency (Agencies) failed to supply the confirmed Raw Honey stocks within the stipulated time, the stocks will be purchased in the open market or from second lowest bidder and excess cost if any incurred will be recovered from the defaulting Agency concerned besides forfeiting the Security Deposit and keeping the firm in the black list.
- 15. The EMD amount deposited will be refunded soon after completion of delivery of Raw Honey stocks at Honey Unit, Chittoor/Rajahmundry.
- 16. Agencies should quote the rates inclusive of GST and transport. The Purchase confirmation orders issued on Agencies should issue the bills showing the GST, Transport cost separately at the time of supply of stocks.
- 17. GCC/ MSTC reserve the right to accept/reject any bid without assigning any reason and no claim / dispute whatsoever shall be admissible.
- 18. System generated automatic Purchase order will be issued to the parties within three days from the closure of the e- procurement.
- 19. All the Raw Honey stocks must be supplied to Honey Processing Unit, Chittoor/Rajahmundry.
- 20. GCC shall take delivery in batches of 10 MTs, provided every batch of 10 MTs of Honey shall pass through the FSSAI Quality parameters and Authenticity Tests. The test charges shall be borne by the Suppliers.
- 21. The Suppliers are informed that, the Rock Bee Raw Honey shall meet the FSSAI parameters as per the circular Rc No. 41/2017/M.1 Dated. 09.09.2021 for which GCC will draw sample from every 10 MTs consignment duly keeping double lock to the storage godowns at the GCC Processing Center and the sample will be forwarded to an accredited laboratory like CALF, NDDB, Anand, Gujarath. Only on confirmation that the sample conforms to FSSAI parameters

the consignment they shall be utilized by the GCC Honey Processing Units as per the requisition of the DM, Tirupathi / Rajahmundry or else the consignment shall be taken back at the cost suppliers.

22. The Rock Bee Raw Honey (Multi Floral) stocks supplied to Honey Processing unit, Chittoor/ Rajahmundry should match with the Samples submitted by Agency.

If any Agency supply stocks which do not comply with the FSSAI Quality parameters and Authenticity Tests, the Agency will be held responsible to the stocks and the stocks will be rejected.

- 23. The payment will be done by GCC, CHO, Visakhapatnam after fully verifying the quality of the stocks only and after submission of required documents.
- 24. In the event of any dispute arising between Agency and GCC hereto under this agreement, such dispute shall be resolved through joint discussion between Agency and authorized officer appointed by the VC & MD.

If still the dispute lies, the same shall be settled by way of arbitration. The sole Arbitrator will be appointed by the VC & Managing Director, Girijan Cooperative Corporation Ltd., Visakhapatnam.

- 25. All legal disputes howsoever arising out of the above in relation to this agreement shall be subjected to the jurisdiction of the court at Visakhapatnam only.
- 26. Management reserves all rights to cancel the e procurement event at any point of time without assigning any reason thereof.
